Member absent: Prof. Urmila Barros, DBT nominee who had given prior intimation of her non-availability due to unforeseen circumstances.

- 1. The meeting was chaired by the Director of the Campus, Prof. Sasikumar Punnekkat (the Chairperson).
- **2.** The chairperson read out the approved minutes of the last meeting and set out the agenda which was the proposed mapping of currently running projects vis-à-vis IBSC guidelines, and simultaneously raised the need for an awareness program about IBSC guidelines.
- **3.** A list of seven currently running projects were presented to the committee for assessing the bio safety compatibility of those projects.
- **4.** During the course of discussions, it was felt that there was a need for a questionnaire to be given to a Principal Investigator before assessing the bio safety compatibility of the project.
- **5.** Subsequently, Dr. Samir Damare suggested he can share a standard questionnaire form for bio safety declaration.
- **6.** It was decided that a two-member team comprising Dr. Utpal Roy and Dr. Judith Braganca would be entrusted with the task of preparing a questionnaire for bio safety declaration for the Institute, while a team with Prof. Sunil Bhand and Dr. Sumit Biswas, would be responsible for chalking out the bio safety guidelines.

- 7. It was felt that the containment facilities in the Institute for use and disposal of genetically modified organisms need to be identified and assessed.
- **8.** As a further step, a Bio Safety Level 2 facility was proposed to be constructed as a central facility with funds from the Institute budget.
- **9.** A proposal for having a separate page for the IBSC in the Institute website was mooted. Prof. Bhand also raised the need for having an exclusive e-mail id. for the IBSC.
- 10. The next meeting of the IBSC was tentatively scheduled in the first week of March 2016.
